P0781-100ML lot 0000115461 contains some vials with the incorrect expiration date on the label. The correct expiration date is August 2022, as it appears on the Certificate of Analysis; however, some labels inadvertently list the expiration date as August 2023.

Reason for the Notification

An incorrect expiration date is printed on some of the labels of lot 0000115461 of product P0781-100ml Penicillin-Streptomycin.

The correct expiration date is August 2022.

Corrective Action

The lot 0000115461 was restricted from future distribution in all warehouses.

Corrective Actions, including procedural updates, process changes, and training, are in process to prevent future recurrences.
